
HUD awards Pathways \$125K to fight housing discrimination in Delaware

Delaware Municipal Electric Corporation sends crew to the Navajo Nation to bring electricity to homes for the first time

The Delaware Municipal Electric Corporation (DEMEC) sent four line workers (two from the Town of Smyrna and two from the City of Milford) to the Navajo Nation to power homes that have never had electricity.

DEMEC is joining crews from other community-owned electric utilities across the nation in an effort known as "Light Up Navajo." This is a pilot initiative of the American Public Power Association to support electrification efforts by the Navajo Tribal Utility Authority, the public power utility serving the Navajo Nation.

"We are proud to help power homes in the Navajo Nation on behalf of our community as a part of this historical initiative. Our members were eager to help when they heard about the situation," said Kimberly Schlichting, COO – SVP Power Supply for DEMEC. "That is the true spirit of public power — helping each other in times of need and powering communities together."

Of the 55,000 homes located on the 27,000 square mile Navajo Nation (roughly the size of West Virginia), approximately 15,000 homes do not have electricity. These represent 75% of all U.S. households that do not have electricity.
