#### Eligibility:

- Programs must be in place for at least 2 years and show measurable results.
- Programs must be growth oriented.
- Programs must support best teaching and professional practices that systemically improve student skill development and work towards strenghening career readiness.
- Previous applicants are encouraged to apply.
- Previous winners are eligible to apply again with <u>new</u> programs.

#### Step 2 / Submission:

All applications must be submitted online no later than **Thursday**, **January 12**, **2023** at **4:30** p.m. No late entries will be accepted. Please note that materials submitted cannot be returned, but all information remains confidential.

\*\*Each question has a word count limit. The total application, including supplemental documents must not exceed 10 pages. Applications longer than the outlined limits will not be accepted.

#### Step 3 / Application Review:

All completed applications will be reviewed and evaluated by the Superstars in Education and Training Selection Committee. Early February, site visit teams will conduct on-site evaluations of potential finalists. Winners will be identified and notified by mid-March.

#### Step 4 / The Awards:

Honorees will be presented with a special award recognizing their superior achievement on **Monday**, **May 8**, **2023** at **4:45pm** in the Doberstein Admissions Center at Wilminton University. Marketing and recognition will be given to all the Superstars throughout the year.
